For the security of your personal data, our Bank may request information from the applicant for the purpose of verifying identity and authorization. To enable the evaluation of your application and the processing of the timeframes specified in the second paragraph of Article 13 of the PDPL, it is imperative to send/submit this form and the information and documents requested from you based on the nature of your request to us in a complete and accurate manner.
